### GENERAL INFORMATION

Applicant: City of Bloomington (Resident Requested)

Request: Parking Ordinance Amendment: W 102<sup>nd</sup> Street between Pleasant Avenue and Nicollet Avenue

### REQUEST

The City has received a request from a resident on W 102<sup>nd</sup> Street to allow on-street parking on W 102<sup>nd</sup> Street after the striping modifications have been implemented (4-lane to 2-lane conversion during construction season 2010). The resident requested either allowing parking any time or “No Parking 7am to 9am, 3pm to 6pm, Monday –Saturday”.

### BACKGROUND

This segment of W 102<sup>nd</sup> Street currently has parking restricted, “No Parking, 24 hours”. However, the segment of W 102<sup>nd</sup> Street between Pleasant Avenue and Lyndale Avenue has “No Parking 7am to 9am, 3pm to 6pm, Monday – Saturday”.

### SURVEYS

Resident surveys were mailed on February 22, 2010 to each adjacent property owner on W 102<sup>nd</sup> Street between Pleasant Avenue and Nicollet Avenue. The results of the resident surveys will be provided to the Planning Commission prior to the public meeting.

### REQUESTED COMMISSION ACTION

At the meeting, staff requests a discussion on the requested changes, the resident survey results and a recommendation to Council on whether or not to pursue a parking ordinance amendment to modify parking restrictions on W 102<sup>nd</sup> Street. If the Commission recommends that the Council approve the requested change, a Public Hearing will be scheduled and advertised.
