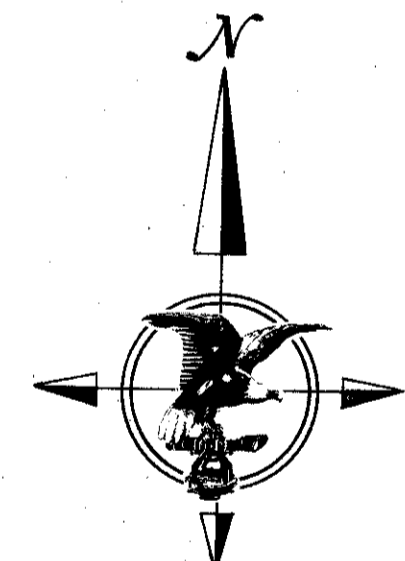
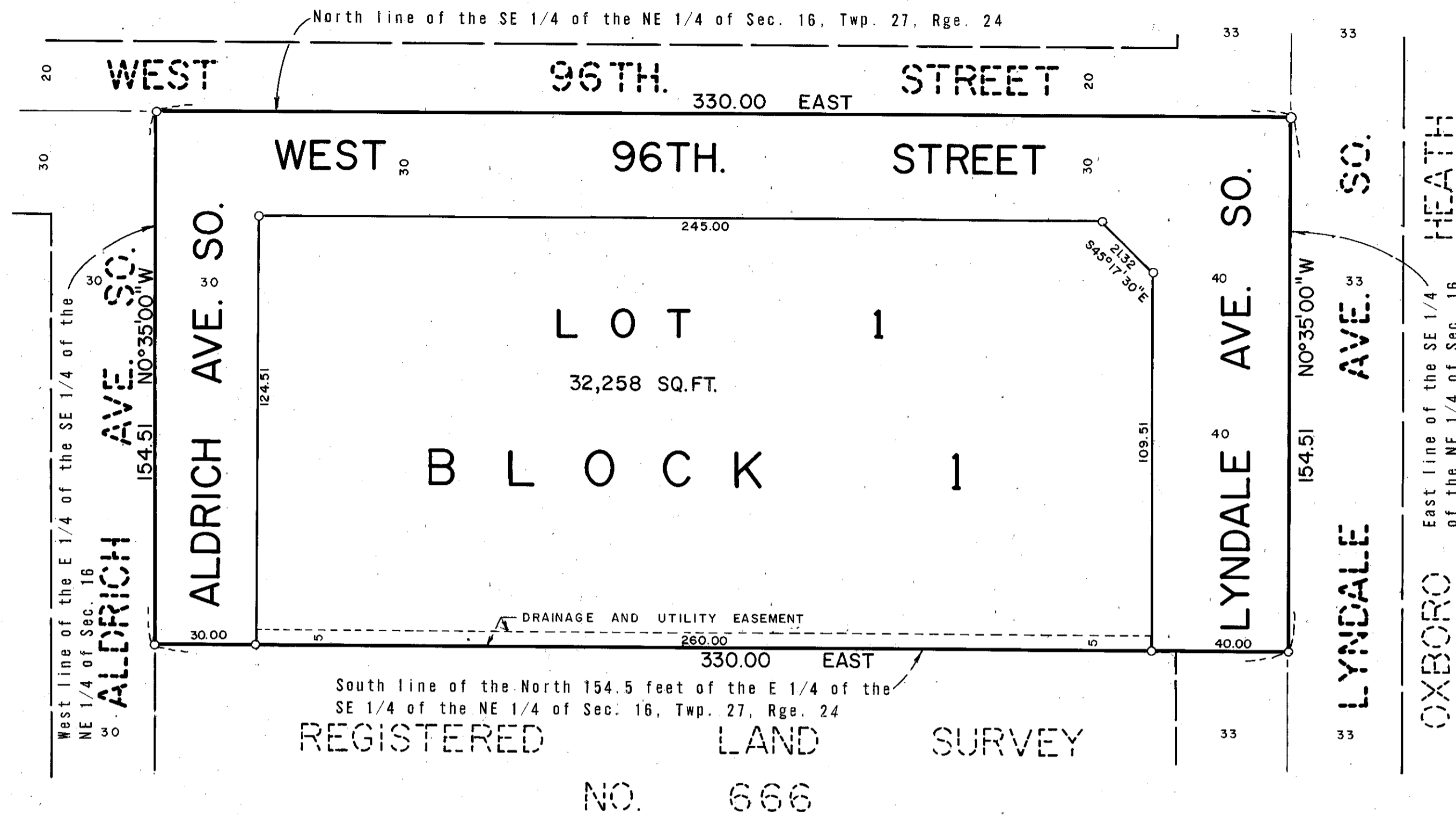


# WHITE CASTLE 1ST ADDITION
